The undersigned counsel to the Debtor and Debtor in Possession (the “Debtor”), in the above captioned case, hereby certifies the following:

1. On July 30, 2009, the Court entered the *Administrative Order Establishing Procedures for Interim Monthly Compensation of Professionals* (the “Interim Compensation Order”) [Docket No. 93].

2. In accordance with the Interim Compensation Order, on December 30, 2009, Debevoise & Plimpton LLP (“Debevoise”) filed its *Fourth Monthly Application for Compensation and Reimbursement of Expenses as Special Corporate and Litigation Counsel to the Debtor for the Period from November 1, 2009 through and including November 30, 2009* [Docket No. 490] (the “Application”) with the United States Bankruptcy Court for the District of Delaware.

3. Pursuant to the Notice of Application, objections were due January 19, 2010. Personnel at Greenberg Traurig, LLP have reviewed the Court’s docket in this case and no answer, objection or other responsive pleading to the Application appears thereon. As of February 1, 2010, no objections or responses to the Application have been received.

4. Accordingly, pursuant to the Interim Compensation Order and the Application, the Debtor is authorized to pay Debevoise 80% of the fees requested in the Application, or \$54,279.20 and 100% of the expenses requested in the Application, or \$4,384.91.
